Each year, scholarships from the former NSW Cookery Teachers' Association fund may be awarded to students from NSW Government School Institutions embarking on a Teacher Education Program with the intention of becoming teachers in Food Technology, Community and Family Studies (CAFS), or Hospitality (VET programs) or equivalent of Home Economics in NSW Government Schools.

TERMS AND CONDITIONS

To be eligible for this award a student must have completed study and obtained a pass in the area of Food Technology, Hospitality and/or Design and Technology (or equivalent) at Higher School Certificate level.

The award is currently for two thousand dollars (\$2,000.00) per annum, tenable for a maximum of four years, pending continuation of study within the agreed discipline.

Application for payment of the second year and subsequent scholarship renewals are to be made in writing using this renewal form no later than 1 February of the year for which the scholarship applies.

- it will be incumbent on the student to make the application in subsequent years
- payment will be subject to satisfactory results from prior years for which certified and printed evidence of results from the institution attended by the student will be required to be submitted along with the application form.
- Certified proof of re-enrolment from the institution must also be submitted
